# RESPONDING TO & REPORTING Child Protection Concerns, Allegations or Disclosures

### SOME WAYS YOU MAY BECOME AWARE THAT ABUSE IS HAPPENING

People may tell you about:

- Abuse that is happening to them now current.
- Abuse that happened to them some time ago historical.
- Something they've been told by someone else and that they strongly believe is true.

You may witness or people may tell you about:

- · Signs of abuse, such as physical injuries to a child.
- Something such as, the behaviour of an adult to a child that made you/them feel uncomfortable.

#### IF A CHILD BEGINS TO TELL YOU ABOUT ABUSE

Children may tell an adult they are being abused if they feel they can trust this person. This happens for many reasons but the important thing to remember is that if they do tell, they are doing so in the hope that the abuse will be stopped. This is true even if the child asks that nothing be done with the information.

If a child tells you about abuse it is important that you: Listen, Record and Report

#### DO:

- Stay calm and listen give the child time to say what she or he wants to say.
- Listen carefully and attentively; take the child seriously.
- Reassure the child that they are doing the right thing.
- Explain that you will need to discuss this with someone else.
- Record the disclosure as carefully as possible; outline what the child said, in the language the child used.
- Inform the Parents/Guardians of the disclosure unless doing so could put the child/young person at risk.
- Report the child's disclosure to the Diocesan Designated Person immediately.
- If there is a serious risk or danger for the child concerned please contact the HSE and/or An Gardai immediately.

#### DO NOT:

- Panic.
- · Ask leading questions or make suggestions.
- · Stop the child recalling significant events.
- Ask probing questions or make the child repeat the story unnecessarily.
- Promise to keep it a secret.
- Express opinions about the child or members of his or her family.





#### IF YOU HAVE A CONCERN

If you have a child protection concern or wish to report and allegation of child abuse please contact one of our Diocesan Designated Persons, who are responsible for receiving/managing concerns and complaints relating to safeguarding children that involve church personnel.



#### A WORD FROM THE BISHOP

The last 18 months have seen significant advancements in our commitment to the work of Safeguarding Children in our Diocese. This Newsletter, which is the fourth publication of this nature, details all major advancements at both national and diocesan levels and serves to communicate the Diocese's on-going commitment to Safeguarding Children.

Key among these developments has been the Review by the National Board for Safeguarding Children of Safeguarding Practice in the Diocese of Elphin. This was a landmark report in the history of the Diocese in that it was the most comprehensive, independent and objective assessment to date of our Safeguarding Practice including our management of allegations and expressions of concern.



I'm greatly heartened by its findings, which are very encouraging, with the auditors highly commending the Diocese across all seven standards of current Safeguarding Practice, indicating that we had particularly excelled in the area of establishing a safe environment for children and those who minister to them within the context of the Church. I encourage you to read the summary of its findings contained in this newsletter and the full report which is available on the safeguarding section of our website. It is imperative now as we move forward that we continue to enhance and develop Safeguarding Practice with even more vigour than before so that the great results we have achieved to date will not be undone but will rather continue to develop into the highest standard of best practice across all parishes in our Diocese.

Again I want to renew my heartfelt thanks to all who continue to participate in our Diocesan Safeguarding Structures, in particular to our Priests, Designated Persons, Trainers, those who act in a voluntary capacity on our committees and as local safeguarding representatives in our parishes. This work would not be possible without their on-going dedication and commitment.

Finally I want to acknowledge the enormous work done by Fr. Ray Browne who has held the position of Designated Person for the last four years and congratulate him and wish him every blessing as he takes on his new role as Bishop of Kerry.

I entrust the continuation of this indispensable work to the care and intercession or Our Lady, and pray for renewal of our Church especially among our young people.



#### DIOCESE COMMENDED FOR SAFEGUARDING PRACTICES

An independent Review of Safeguarding Practice in the Diocese of Elphin, which was carried out by the National Board for Safeguarding Children in the Catholic Church in Ireland (NBSCCCI), has commended Bishop Christopher Jones and the Diocese of Elphin for putting in place comprehensive policies, procedures, structures and practices to safeguarding children and handle allegations and expressions of concern relating to child abuse.



The *Review* published on the 24th April 2013 is a result of an on-site audit of safeguarding practice in the Diocese conducted by the National Board for Safeguarding Children in the Catholic Church in Ireland (NBSCCCI) at the request of Bishop Jones during November 2012. It measures current safeguarding practice in the Diocese against the 48 criteria under 7 Safeguarding Standards which have been developed by the NBSCCCI in line with statutory guidance and best practice in the area. As well as reviewing the proactive safeguarding measures and structures in the Diocese the auditors reviewed case files and conducted interviews with key safeguarding personnel.

The Review highly commends the level of safeguarding practice in the Diocese across all seven standards, indicating that the reviewers "were supplied with an impressive range of documentation ... of a very high standard, well produced and easily accessible." The reviewers also indicate that "in many respects, the documentation represents an excellent example of the standard that should apply across all of the church in Ireland." In terms of establishing a safe environment for children the Review states "that this is an area where the diocese has excelled." The reviewers commend the Bishop for his investment in safeguarding and in particular for appointing a full-time permanent Director of Safeguarding who is responsible for safeguarding practice in conjunction with the Safeguarding Committee. They also commend the support given to safeguarding by enthusiastic and committed people at both diocesan and parish level.

### Review of the Processing of Complaints and Expressions of Concern

The Review process dealt with complaints and expressions of concern against clergy received from January 1975 to November 2012. The Review states that "the overall incidence of abuse allegations within the diocese is not unusually high. They do contain a significant number of allegations which upon investigation were shown to be unfounded." The Review indicates that while there were some delays in reporting in the past "through a belief that they had been reported or through a misunderstanding that another Church authority had already done so. The impression gained by the reviewers was that practice in this area has become much tighter in recent years."

Current reporting procedures and practice in the Diocese are in line with statutory and church best practice.

#### **Number of Criteria Met and Recommendations Made**

Out of 48 criteria the Diocese has "fully met" 47 criteria and "partially met" one at the time of the Review. The one criterion "partially met" refers to the gathering of feedback on policy and procedures from parents and children. While the Diocese includes feedback from parents, children and other stakeholders as part of its current policy for periodically reviewing its safeguarding practices, the NBSCCCI asks that the next revision of the policy document includes concrete examples of how feedback from parents and children is gathered.

The Review lists six recommendations in total as to how the Diocese can continue to ensure it enhances and develops its safeguarding practice into the future. These recommendations range from the incorporation of very recent developments in church safeguarding guidance into the next revision of diocesan safeguarding policy and procedures, to ensuring that Bishop Jones' successor receives a comprehensive induction into what safeguarding activities take place in the diocese. The Diocese, through its Safeguarding Office, has developed an implementation plan for all six recommendations.

### Reassurance for all Involved in the Life of the Church in Elphin

The Diocese hopes that the publication of the *Review* will reassure parents, children, clergy, volunteers and the general public, that the Diocese has put in place all proactive and preventative measures possible to ensure the safety of children and volunteers into the future. It also affirms that the Diocese operates robust procedures to promptly, sensitively, and professionally deal with all complaints and expressions of concern in conjunction with the HSE and An Garda Síochána.

# GARDA VETTING, SAFEGUARDING TRAINING, NCMRG AND GUIDANCE ON LEAVE FROM MINISTRY

#### **VETTING OF PARISH VOLUNTEERS**

The recent Parish Audits which were completed by the Diocesan Office for Safeguarding Children identified volunteers in each parish who have substantial unsupervised contact with children. These volunteers have been invited to take part in an in-service training evening in each deanery which is designed to cover core safeguarding policies and procedures. Part of this training includes training on safe recruitment practices. Each volunteer in attendance has been asked to submit for Garda Vetting and the completion of other recruitment policy requirements as per our Diocesan Safeguarding Policy and Procedures.

#### SAFEGUARDING TRAINING

During the last year NBSCCCI accredited training was offered to all Priests and Parish Safeguarding Representatives of the Diocese. The training which was part of their annual in-service covered 2 of the 4 modules from the new Safeguarding Materials. The remaining 2 modules will be offered to all Priests and Safeguarding Reps during their scheduled annual in-service training in Autumn 2013. HSE Keeping Safe Accredited Training was also delivered to the Diocesan Case Management and Safeguarding Children Committees and other Key Personnel during January and November 2012.

## NATIONAL CASE MANAGEMENT REFERENCE GROUP (NCMRG)

The National Board for Safeguarding Children in the Catholic Church in Ireland established a National Case Management Reference Group in January 2012 on a pilot basis. The group's membership is comprised of members of the National Safeguarding Office, Social Workers, Civil and Canon Lawyers and others. Their remit includes the provision of high-quality advice to bishops and religious superiors/provincials when they are called upon to respond to safeguarding cases. The advice focuses on the management of the investigation and assessment processes and may comment on the 'fitness for ministry' of the respondent. Between January 2012 and March 2013 the NCMRG reviewed 67 cases belonging to 12 dioceses and 20 orders/missionary societies. Following the positive evaluation a proposal has been made to ensure that the NCMRG becomes a permanent aspect of the services offered by the National Board.

### GUIDANCE ON LEAVE AND RESTRICTION FROM MINISTRY

The Bishop/Congregational Leaders possess all the necessary powers to take measures to promote the safety and welfare of children. Among those actions may be the requirement to restrict a respondent's exercise of his/her office, sacred ministry and apostolate if and when an allegation is received. To this end the National Board for Safeguarding has issued a document which offers guidance to bishops and congregational leaders when leave and restriction from sacred ministry and apostolate is required of an individual as a result of an allegation. The document was produced following an extensive consultation process and is available for download on www.safeguarding.ie
